Annual General Meeting - Monday, 18 February 2019

1. 2. 3. Welcome, Apologies and Confirmation of Minutes

- Marc opened the meeting at 7.09pm and welcomed all. Apologies were noted as above.
- The draft minutes from the 2018 Annual General Meeting were accepted as final.
Action: **Jason** to arrange publication on school website.

4. Activities of the Association During 2018 – President’s Report

- Marc thanked everyone who’d volunteered their time and energy to make 2018 a success for the P&C and school, both socially and financially. Marc noted several highlights from the year - Attachment A provides Marc’s tabled report.

5. Statement of Accounts 2018 – Treasurer’s Report

- Justine took the group through the statement of accounts (Attachment B) and thanked everyone who’d worked to raise funds for the school via the P&C’s activities. New fundraisers during 2018 included the Mango Drive and Entertainment Book sales. She noted that the Fete’s financial result was substantial. The support from the Southern Cross Club was also appreciated. Justine noted a need to account for depreciation.
- Marc noted the delay in finalising the 2017 audit was nearly resolved, and would be completed concurrently with the 2018 audit.
Action: **Marc and Justine** to complete audits.
- Rebecca Reilly requested clarification on the clothing pool funds which showed a loss, which Justine took on notice, later providing the following explanation:
 - The figures show a loss over 2018, but this is because of significant purchases made or paid for in other years. Overall, the 2017 books show of surplus of \$9285.43, the 2018 show a loss of \$11,756.22, and January-February 2019 show a surplus of \$4228.75. From January 2017 to February 2019 the Clothing Pool returned a surplus of \$1757.96.

6. Election of Office Bearers

- John was appointed Returning Officer, and invited nominations. Each person was nominated validly and elected unopposed as follows:
 - President – Marc Dal Cortivo
 - Vice President – Mac McCann
 - Treasurer – Justine Bourke
 - Secretary – Jason de Rooy
 - Committee Member – Rebecca Reilly
 - Committee Member – Karen Carmody
- Marc noted the Committee's role in practice was primarily to manage the Association between meetings, where all parents and citizens are invited to have a say.
- The meeting agreed to the extension from the previous year of Justine Bourke, Mac Dal Cortivo and Mac McCann's having online access and roles as signatories for the Association's bank accounts. Joanne Hann would be added to the Clothing Pool account.
- The meeting agreed to account transfer daily limits for Justine Bourke (Treasurer) of \$20,000, Marc Dal Cortivo (President) of \$5,000, and Mac McCann (Vice President) of \$5,000, as per previous years.
- The group agreed to the following appointments for 2019:
 - Public Officer – Marko Matosevic
 - Clothing Pool Coordinator – Joanne Hann.
- Marc extended his thanks to Karen for her years as formal Clothing Pool Coordinator, and for continuing to be available to help out.

7. Close of AGM and Next Meeting

- To ensure clarity, Marc closed the AGM at 7.29pm, with the intention of immediately opening a General Meeting of the association. This will enable the minutes of the General Meeting that follows to be approved at the following General Meeting.

President's Report for Annual General Meeting - 18 February 2019

The Wanniasa Hills Primary P&C Association had another highly successful year throughout 2018. Our success is directly attributed to the time, effort and experience of our committee members that manage to continually improve on and run our events smoothly each year.

I'd like to thank our members, volunteers, students and school staff for their commitment of time and energy that has made this year and such an enjoyable experience, and I'd also like to specifically thank one of our hardest working and well-respected outgoing volunteers, Emma-Kate McGuirk.

In 2018, we focused on supporting the school, providing services, fundraising, spending funds, and advocacy.

Supporting the school

The 2018 P&C Committee supported the school through many events, including but not limited to; opening the canteen for the special lunch day, catering at school events, organising in-class volunteers, and helping at the sports carnivals.

Providing services

The P&C Committee also provided services to the school community such as operating the canteen and clothing pool on a volunteer basis and facilitating the walk/ride to school day for the students.

Fundraising

As at January 2019, our main bank account held just over \$69,000, so we are well placed to hand over a healthy amount to the incoming committee. Our successful fundraising activities included the Mother's and Father's Day stalls, the school disco in June, our trivia and murder mystery nights, various sausage sizzles and the biggest earner, our Fete. The Mango Drive and Entertainment Book fundraisers were also highly successful this year.

The P&C also received ongoing financial contributions from the Canberra Southern Cross Club's generous school rewards program.

Spending of funds

As a result of the 2017 P&C agreeing to contribute ongoing funding towards the school Playground Landscaping effort, the 2018 P&C donated \$10,000 to be directed towards cost of the new 125,000 litre water tank. We also donated a further \$10,000 for the school's Science, Technology, Engineering and Math (STEM) initiative, which helped fund the two new 3D Printers.

In addition to the two major donations, the P&C also:

- Purchased the school a new greenhouse for \$2,200
- Supported the 2018 School Musical with a \$2,000 donation
- Supported the Year 6 Graduation with a \$1,150 donation
- Supported the McCann Properties Easter Fair with a \$1,000 donation

Advocacy

The P&C has provided responses to all applicable requests for feedback and surveys on issues that were raised by the P&C at Council. In addition, where required, P&C Delegates attended P&C Council led meetings/information sessions throughout the year.
