 - o Need to check availability of rides first
 - o Maybe have a petting zoo
 - o Look to hold the Fete around end of October
 - o The community are ready to meet again and have something fun on perhaps we call it a 'Community fun Day'
 - We could put an advertisement on the P&C Facebook page and in the school newsletter
 and ask the community if they would be interested in having a school Fete/Community Day

6. Clothing Pool

- Opened clothing pool stall on Saturday 7 May, went well, lot of second-hand uniform sold.
- Wally hoodies have sold-out in most sizes. John investigating a new supplier as Erindale not interested in doing it again.

7. Principal and School Board Report

- COVID restrictions have eased again
- COVID rules around close contact have changed students are not required to isolate at home now with the rest of the household if they are feeling well
- Everyone is still required to wear a mask moving through the school
- Pick and drop off restrictions have relaxed
- The school has managed to keep a regular supply of relief teachers and managed to split classes across the year groups
- Parents/carers were allowed to attend the Athletics carnival held off-site on the 27 April 2022
- School camps and excursions will be going ahead in Terms 2 and 3
- Cross Country will be held on the 24 May
- Monday 6 June 2022 will be a pupil free day teachers will be using this day for lesson planning and completing student reporting
- School assemblies are back on, parents are still not invited. WHPS are continuing to work on finding a suitable and safe method parents can watch/access the assemblies remotely.
- Pre-school Refurb:
 - fencing in the carpark, still no work due to delays and complications
 - the next four weeks will be removing different aspects of the area, then internal refurbishment will start after
 - P&C to gift \$20,000 towards the purchase of new pre-school furniture. This can be given to John whenever
